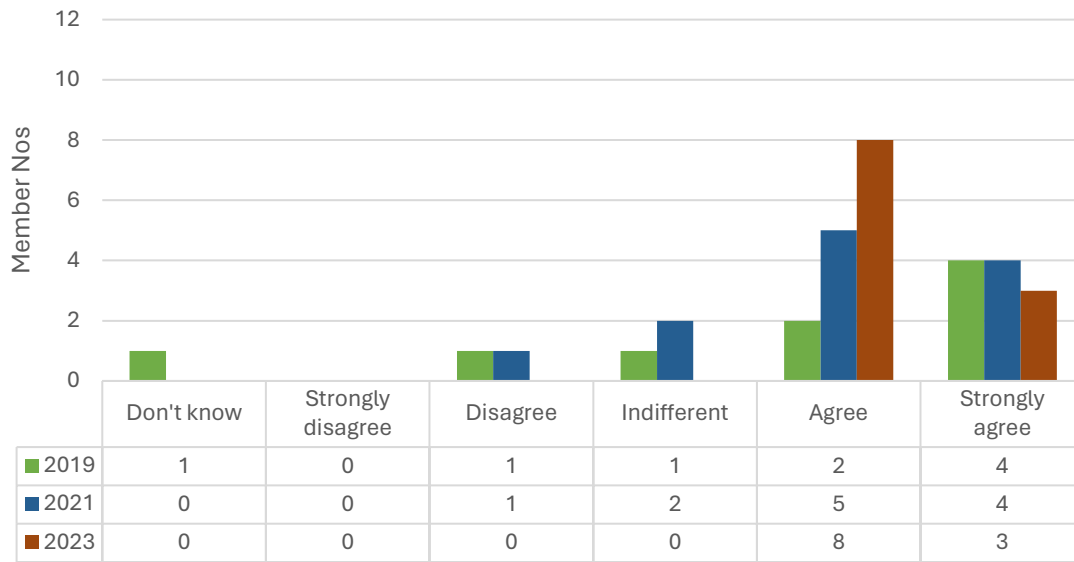

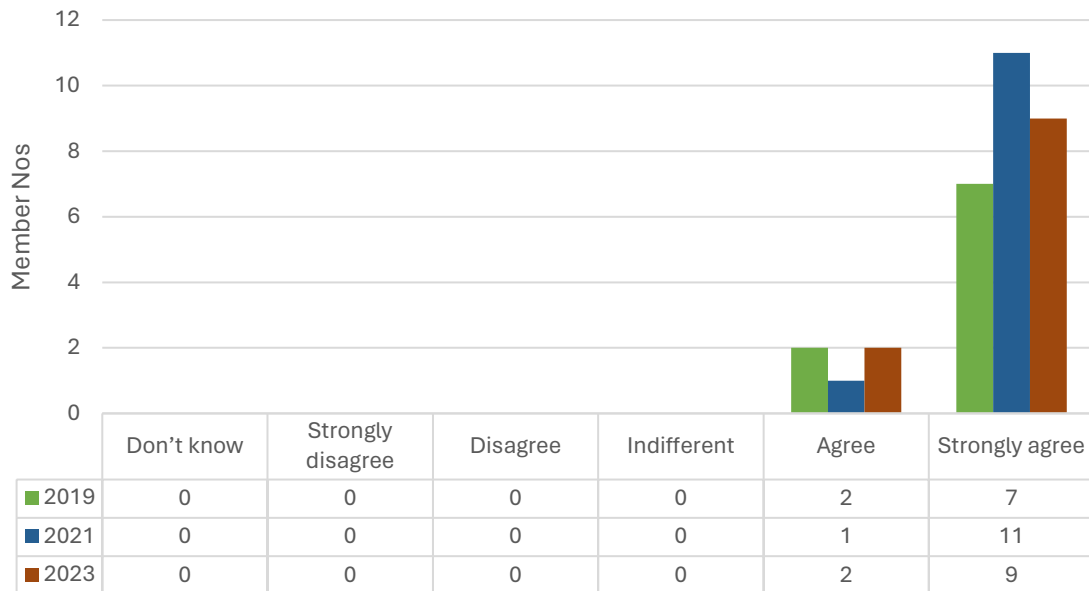

1. The induction procedure adequately prepares new Board members for the role.

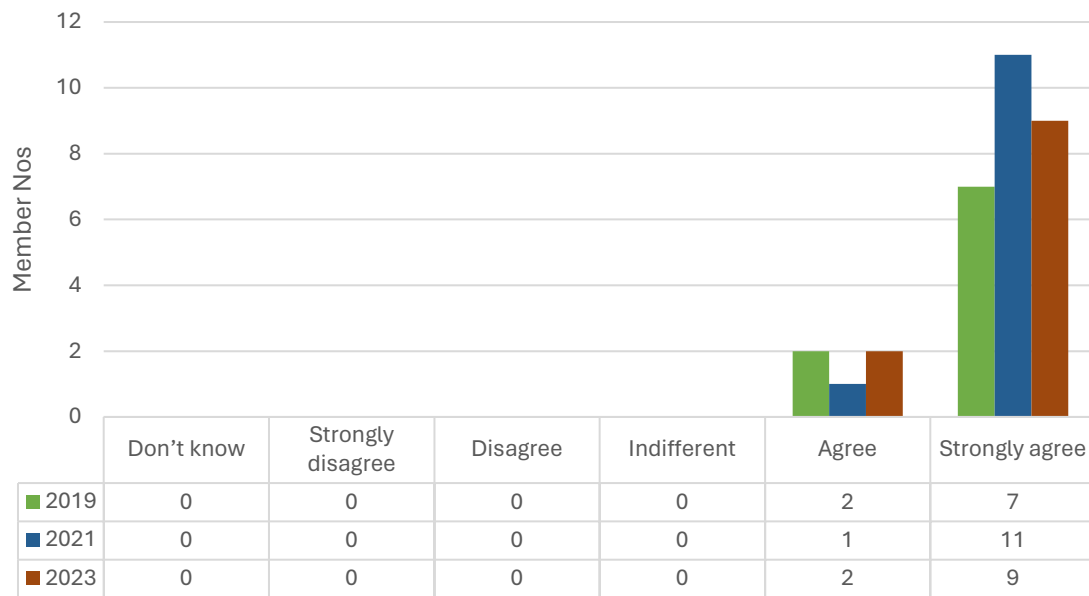


2. Minutes/agendas/reports are received in time to thoroughly prepare prior to meetings.

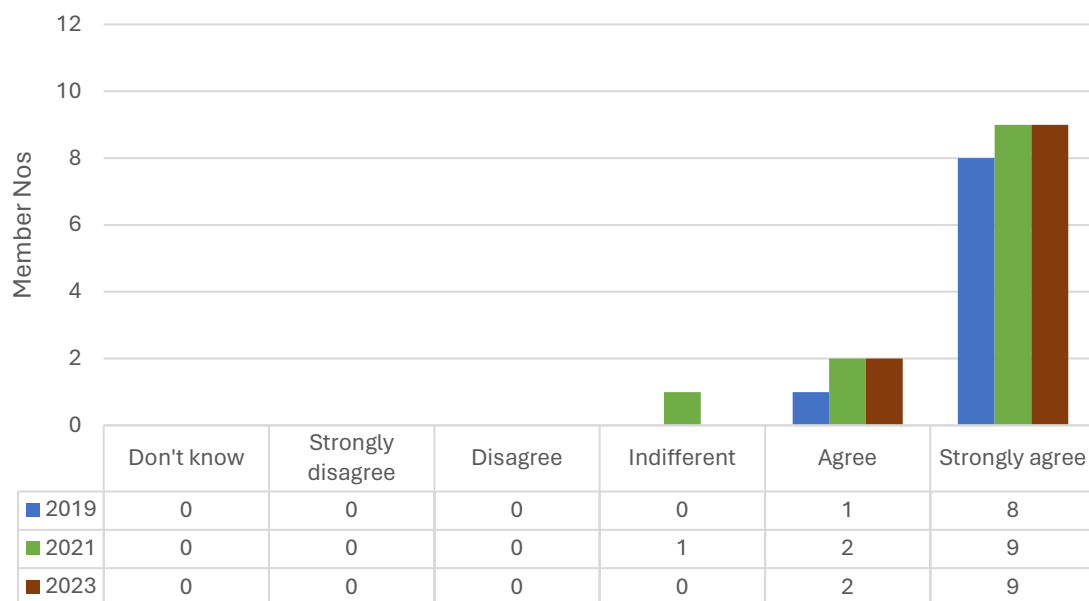

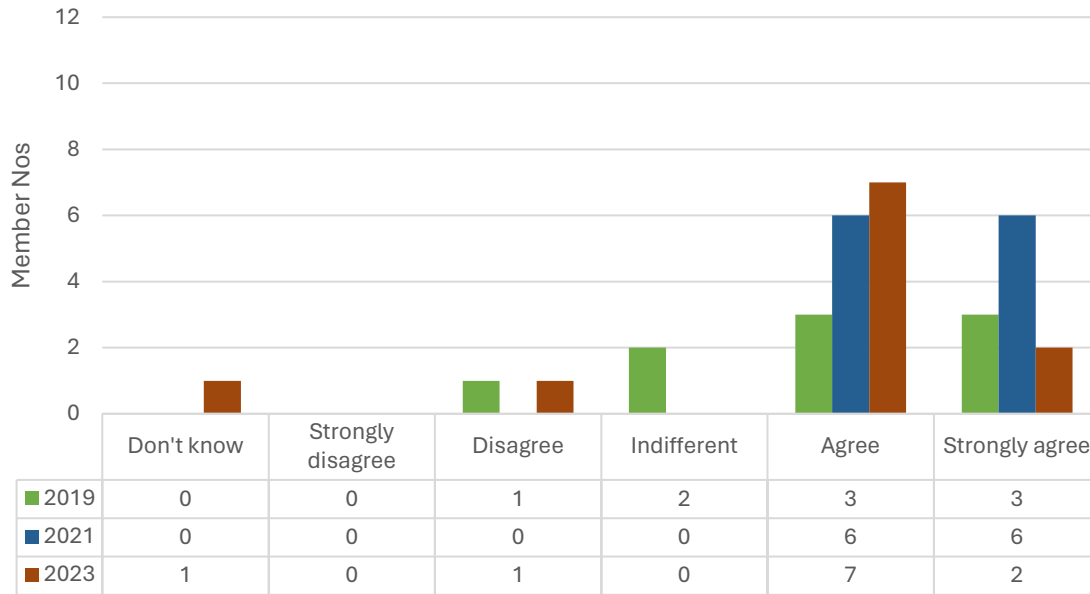
9. The School Board follows good decision-making processes.



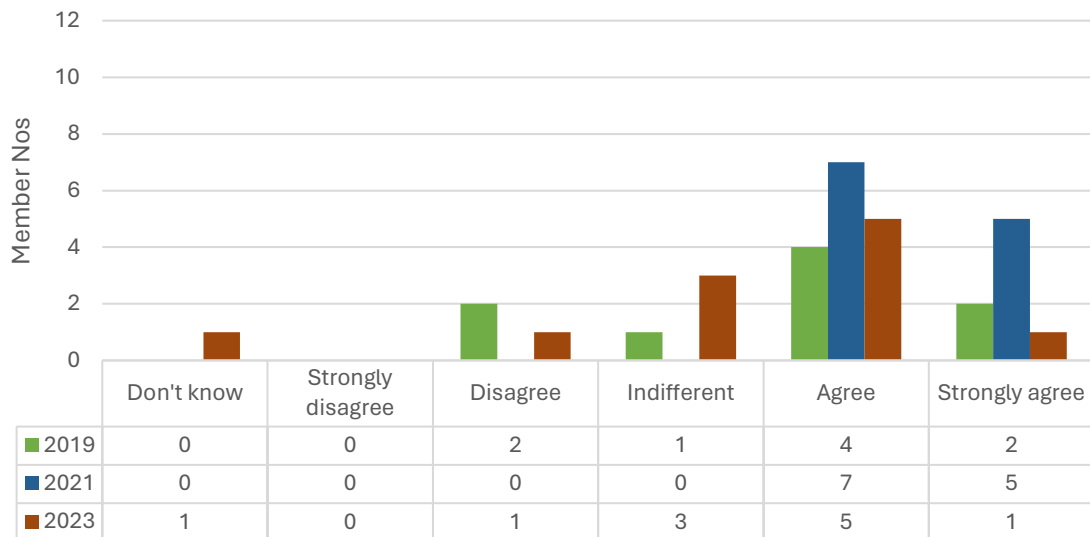

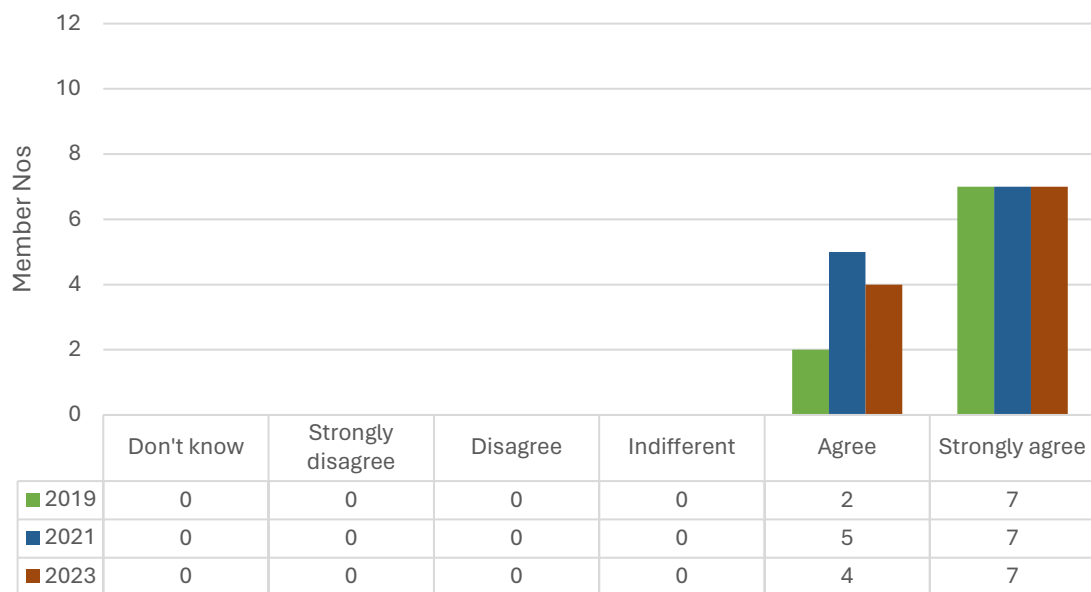
11. The School Board is actively involved in the development of the Delivery and Performance Agreement including the Business Plan.



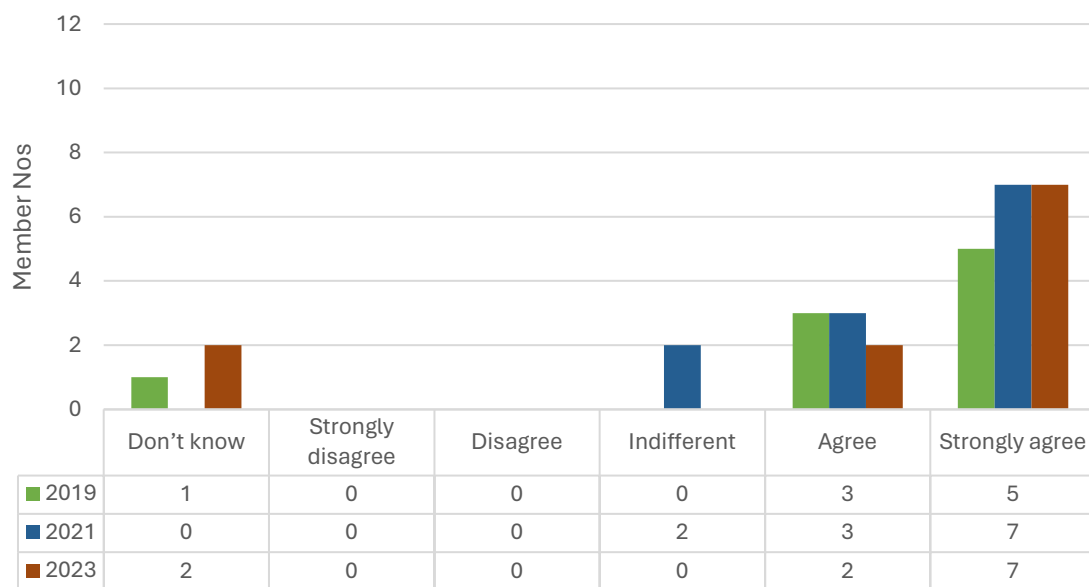

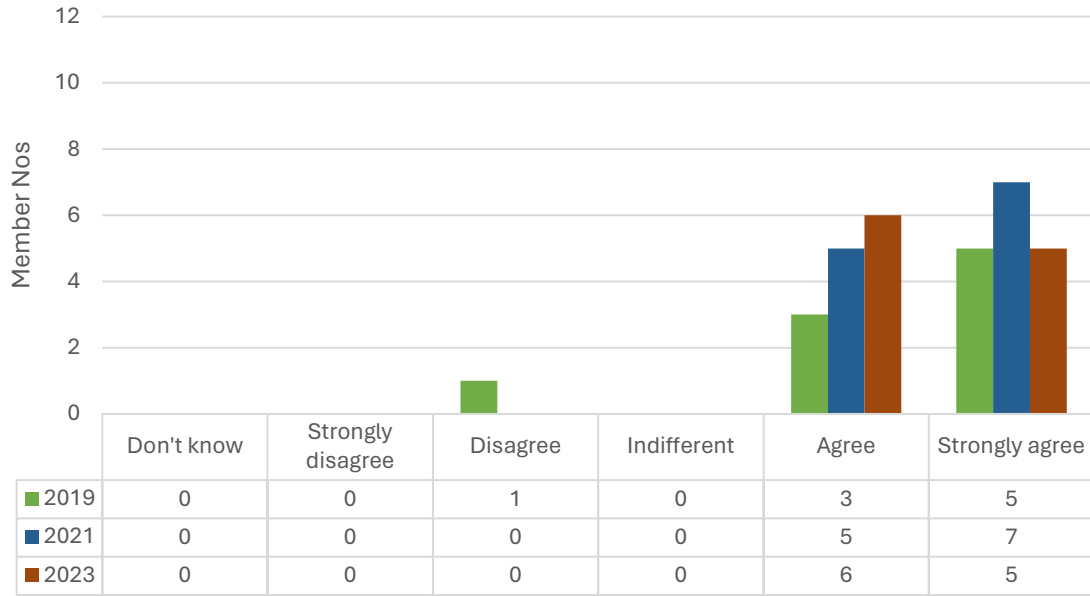
17. Board Members are able to express their opinions freely at meetings.



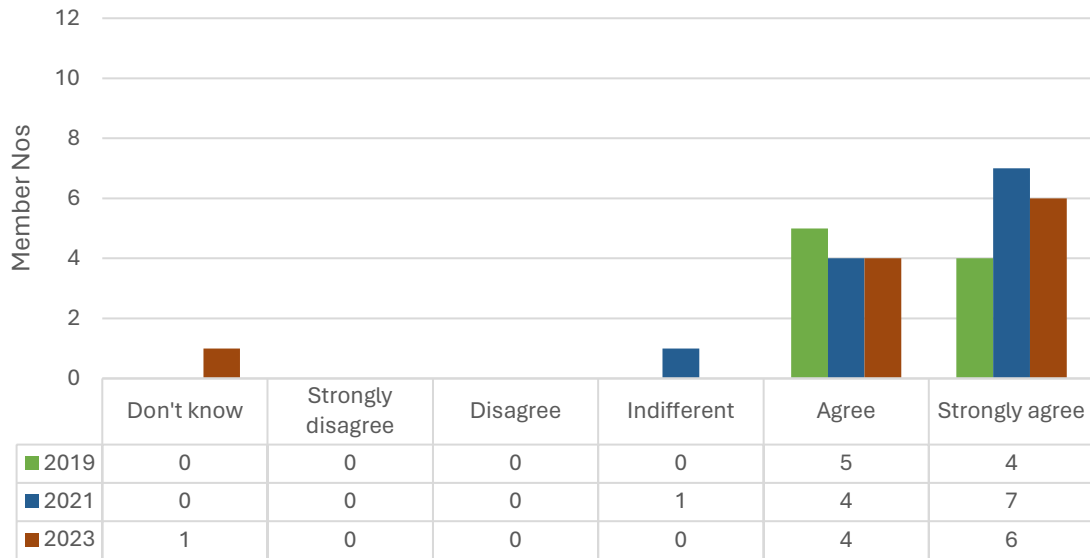
18. There are no individual Board Members who are too dominant during discussions.



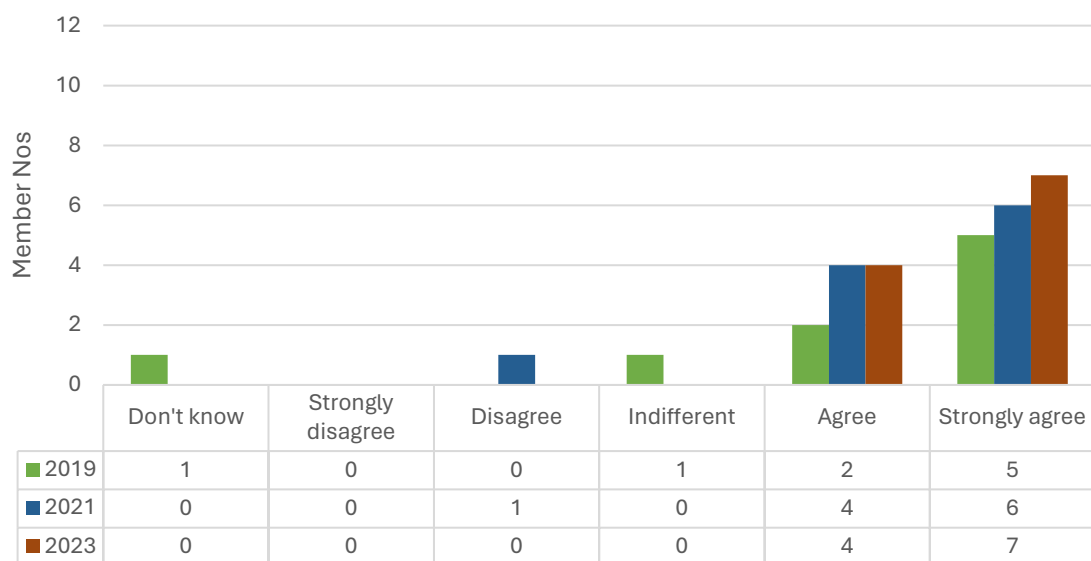
19. There are no individual Board members who are too dominant during decisions.



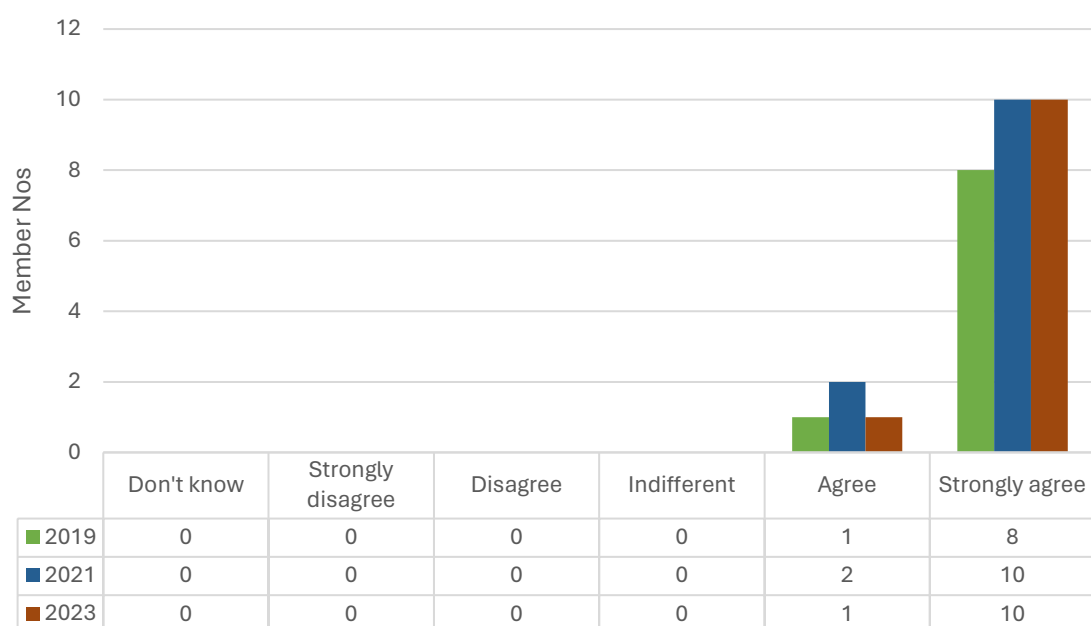
20. The School Board endorses the annual budget based on the recommendations received from the School Board's representative on the Finance Committee.



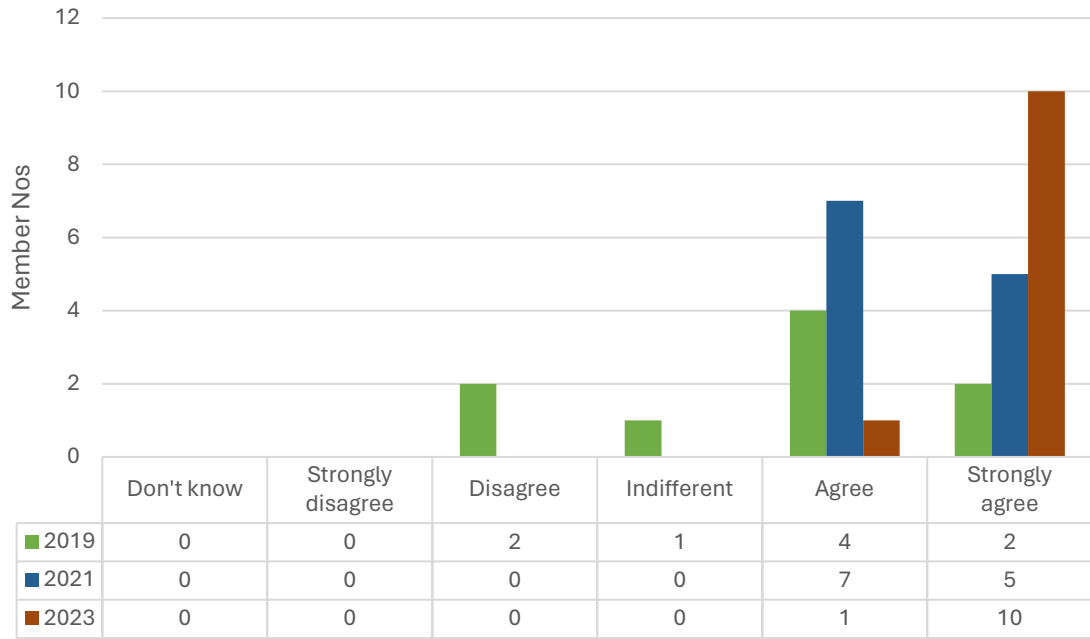

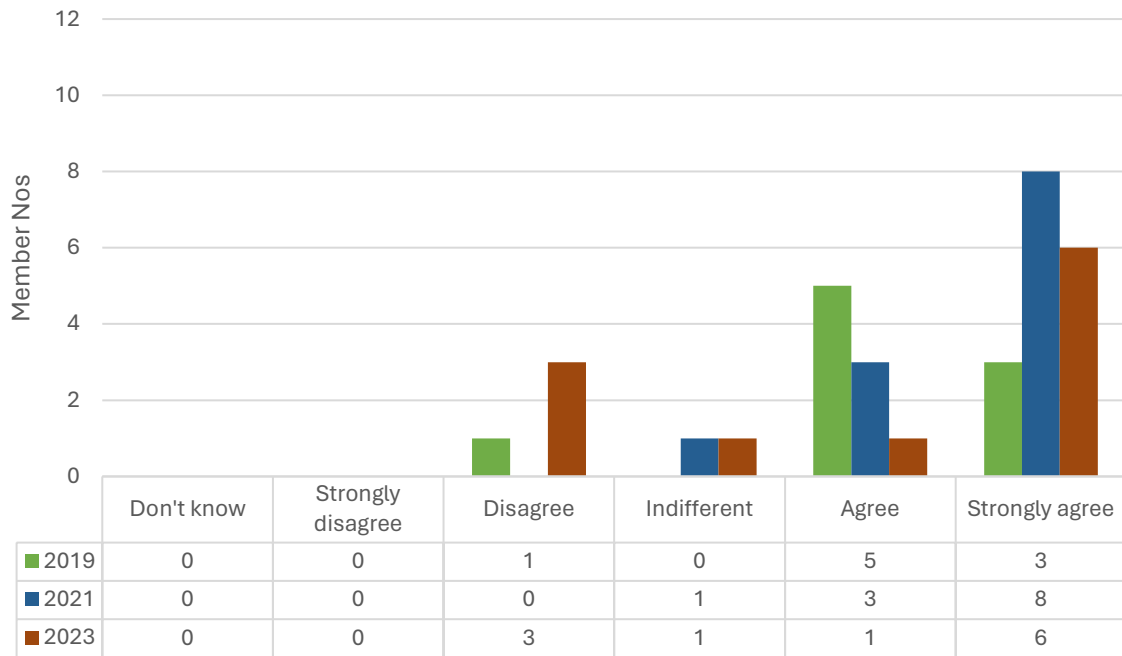
22. The Chair and the Principal have a respectful working relationship.
