

Music Scholarship

The Churchlands Senior High School Foundation will provide students entering the Gifted and Talented music program the opportunity to be the recipient of a Music Scholarship.

The Foundation will grant <u>two types</u> of Music Scholarships; one scholarship for a student who can demonstrate high musical achievement and another for a student deserving financial assistance.

- Students in need of financial assistance must complete the application form and attach all supporting documentation to be considered for a Music Scholarship. These must be sent to the Foundation before the deadline. Please note, late applications will not be accepted. All complete applications received by the due date will be screened to ensure applicants satisfy the basic eligibility criteria.
- The Scholarships for high musical achievement will be awarded based upon school auditions and there is no need to complete the application form or attach any documentation.

The Scholarship will provide a sum of \$2000 in the first year of the program (Year 7) and \$500 in the consecutive years up to their last year of High School (Year 12). The Scholarship aims to assist with expenses related to musical studies and education expenses such as:

- Purchase of a musical instrument
- Stationery and books
- Excursions and camps
- Laptop
- Uniform
- Others

Scholarship recipients must remain enrolled as a Churchlands Senior High School Gifted and Talented Music student for the duration of the Scholarship. If a student leaves the school before Year 12, the Scholarship will lapse.

Basic eligibility criteria

- Eligible to be enrolled or already enrolled at Churchlands Senior High School for Year 7
- Eligible to enter or already enrolled in the Gifted and Talented Music Program
- Be an Australian Citizen or Permanent Resident



Selection process

A selection panel will review all Scholarship applications from students in need of financial assistance. The selection panel will include representatives of the Churchlands Senior High School Foundation and the School of Music. After considering all applications, the selection panel will shortlist applicants for the approval of the School Principal.

For the High Musical Achievement Scholarship, students will be assessed by a selection panel based on the school auditions.

Applicants and candidates will be notified of the outcome through email and if successful, they will also receive a congratulatory letter from the Foundation Chairman.

Application Form and Attachments

The application form and supporting attachments will demonstrate how students meet the selection criteria.

To apply for the Music Scholarship students must complete the application form (attached).

The application must include;

- Academic transcript from previous school
- Supporting letter from the current primary school Principal endorsing the financial need of the family
